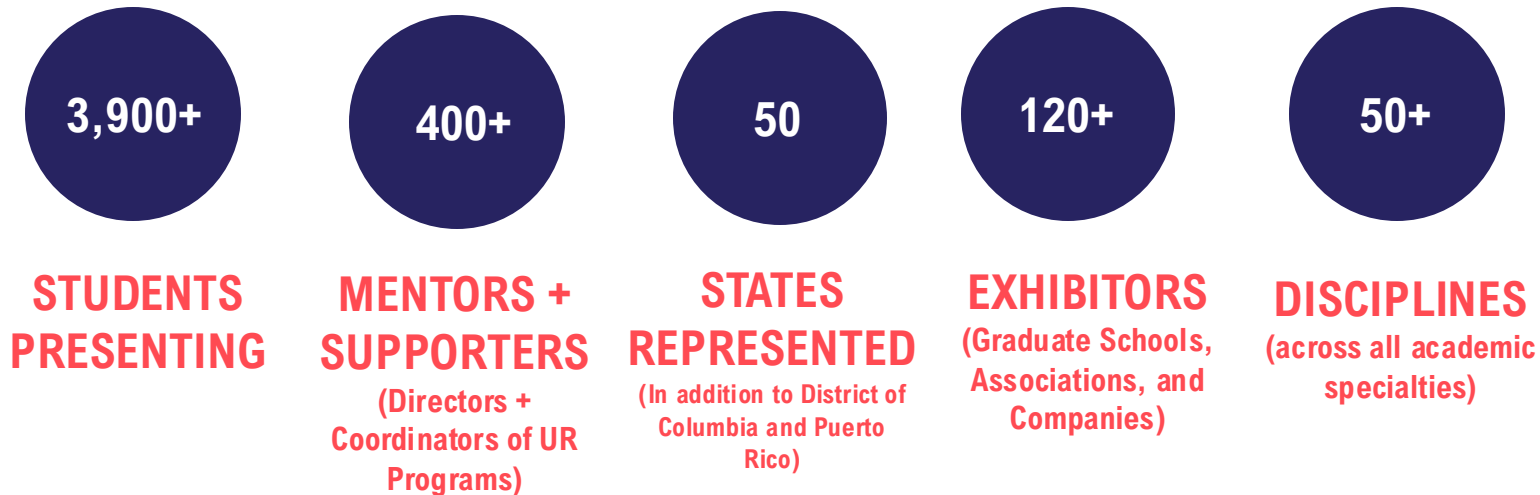
## WHAT IS NCUR?

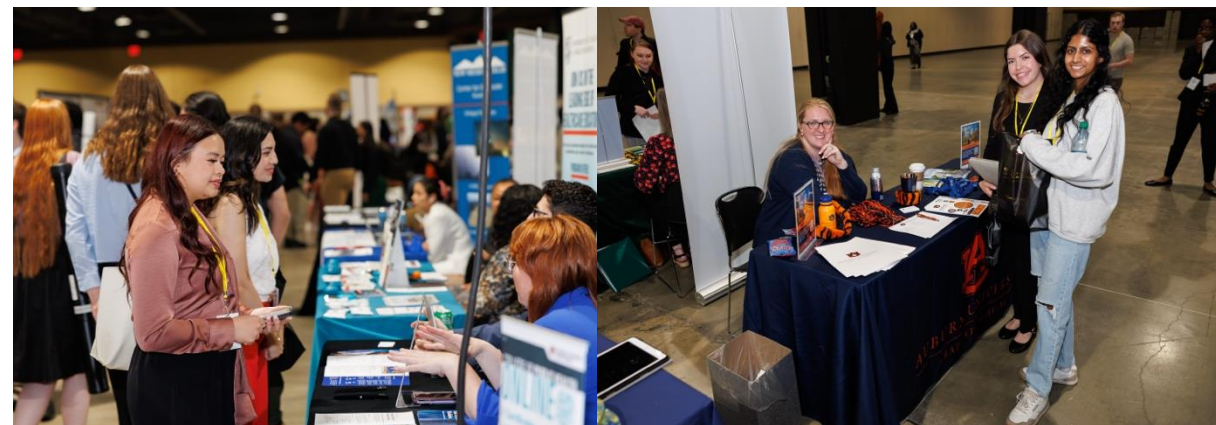

Early Bird (Ends October 10, 2025): \$1750  
Regular Registration (ends February 20, 2026, or when sold out)

Wi-Fi and Electric are not provided but can be ordered for additional fees. If shipping items to the convention center, material handling fees will apply. More information for ordering items for your display and shipping instructions will be included in the Exhibitor Kit.

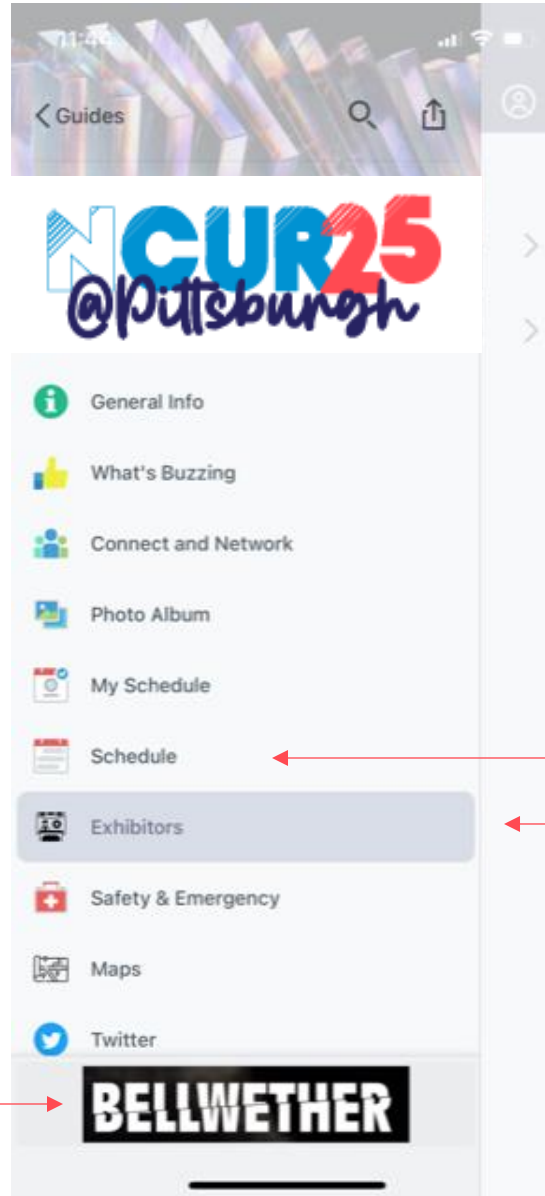


# EVENT APP OVERVIEW
